PART 2: DETAIL SUPPLEMENTARY

I have been a political poi (person of interest) for at least twenty five years or arguably since the day of my birth. My goings since the early nineties have been constantly monitored/harassed by Australian and U.S. media and Australian and U.S. governments conducted in Orwellian actions.

In **PART 11** I make reference to ABC-Radio 666. I have forwarded a written allegation too the AFP (Sydney) against ABC-TV Canberra. The allegation is charged against the ABC of operating a hidden camera surveillance in a residence I was residing at in mid 1995. (The Australian Labor Party was in office at that time). The allegation is in the attention of AFP Officers Jeremy Staunton and Daniel Laveta. I gave the AFP up to the 10th of May to inform what actions they have taken regarding my allegation. They failed to respond. Such decision only extends my certainty that what I alleged took place did. (ABC-TV and ABC Radio 666 are both operated in the same standard size office block; a building of only two levels.)

I have completed this Detail through the use of computers at Sutherland and Engadine libraries. Microfiche research I have conducted at The State Library. I have much consternation in computer use as I am very basic in computer knowledge. I am aware that certain words in computer or electronic communication are soi's (subject's of interest). I'm aware 666 is one of them. I do not know if there is mother board capabilities of duplication in keyboard entry within the library computer system.

Up to the point of handing this Detail over to Strikeforce ANCUD the entirety of the Detail has remained only in my knowledge. I inform that I have verbally disclosed certain particulars concerning issues of exploitation and have in place copies to immediately hand to an array of people throughout the general public.

The Detail is extremely complex mainly as result of the immense subject range; time span and input directions. I recommend starting with **PART 19** then reading from beginning through. To help compact comprehension brief read the questions in first reading.

The Detail is compiled in the principle objective of assisting to achieve justice for three persons who were abducted and killed-sacrificed. There shall also result from this Detail the destruction of a syndication of persons (the 666 trilogy) that wilfully were in knowledge of the sacrifices. Inside that trilogy is a network of high profile identities that have in commercial practice profited and exploited the sacrifices of the three persons particular Evelyn Greenup; they shall also be destroyed.

PART 3: FORWARD

My holding in regard to the subject of sacrifice:

My Definition: A sacrifice is a act of human life offering in the quest of gaining spiritual favour; knowledge or saving:

I hold that a individual has the right to die in his or her own decision upon reaching the age of seventeen years. This right also provides that individual to die in the manner of his or her choosing.

I hold the right for sects; cults or organisations to belong in liberal; democratic societies. If any of these affiliations have within their beliefs sacrificial conduct; I believe in their right to conduct such inside the holding that I have declared on the proviso that the member's of the affiliate before joining are educated that such beliefs are of that affiliates constitution.

This holding is obviously not a statute. I fully recognise the necessity for a statute that would criterion particular circumstances for example: a member been born inside the affiliation.

Big Picture Allegation: - I remind of the document **NOW**

“Our Father Who Art's in Heaven”; “Deliver Us from Evil”.

We all know that these two verses are from The Lords Prayer. The Australian Commonwealth Parliament before sitting; stands and recites The Lord's Prayer. The Australian Commonwealth Parliamentians are Christian Suits.

Prominents of 'The World' have become very ill/sick. My regard of this concern has never been sought by The Prominents of 'The World'; such fact alone must surely hold The Prominents illful in judgement.

My regard ov the heavenly concern is as follows:

Man made change to the degree ov dumb down presentations such as The Al Gore movement are extremely ludicrous. We have recently lived through a seemingly increase ov rainfall along the East Coast ov The Australian Continent. In ignorance and agenda with a monopoly ov media presentation a belief that we are experiencing a change in climatic extremities is slowly been absorbed as a truth.

Not a single pre flood levy was breached is fact. Fact also is that the magnitude ov the recent Queensland floods was a result ov bad management ov water catchments and new residentials been built in known flood plains.

The fact ov truth in regards to the weather up through The East Coast ov The Australian Continent is that the recent five to seven years is a normal cyclical climate sequence. PART 4: EXPLANATION AND BELIEVED CONNECTION TOO EVELYN GREENUP

Ov my introduction and discussion with Detectives Moorfoot and McGregor on 16th November 2011 I informed that I was Evelyn Greenup's male parent. I believed such for a varying of reasons inclusive ov: an incorrect date recollection; a episode ov Australian Story and media exploitation of Evelyn's death. My visit to Evelyn's grave that has a photo which presents Evelyn to have been ov premature birth gave heightened certainty that Evelyn was mine. Since the 16th I refound a old passport that gives me certainty of relevant dates. The passport confirms dates that would place me in Canberra between late April 1987 and early June 1987 not 1986.

The Canberra 1980 dates are relevant because I distinctly recall an interlude with a largess aboriginal female in Canberra. My distinct recollection of that interlude is: Around the hour of 5AM whilst standing amongst revellers at the taxi stand end ov Civic-Canberra; I noticed a aboriginal female on her own. She was squatting very soberly watching the gathering ov revellers. Recognising that her want was in my direction I made acquaintance. We were in a taxi within twenty minutes going to where she was residing. Ov our talk I distinctly recollect her informing, that she was from up around the Kempsey area and that she was planning in a soon time to return home. In that understanding it was mutually recognised and not attempted by either ov us to remain in contact. The interlude was nice; she was nice; there were no issues just a nice connection that included sexual intercourse with a at ease understanding in farewell. I recalled then that a maturity was within her; that she was her own decision maker perhaps with a touch ov morbid knowing that her plans and future may all likely be singular. I distinctly recollect the departing taxi ride and my thinking that she may have gone out that night specifically in hope to target a male in purpose to conceive a baby. If conception resulted in that interlude a birth would in normal calculations been ov around mid February 1988. I forth believed that it be distinctly possible that I am the male parent ov one ov Evelyn's siblings- Aaron; Aden or Lytiah.

PART 5: MY UNDERSTANDING OV ALL THREE DEATHS FROM TELEVISION AND NEWSPRINT

There has been one television documentary and two newspaper articles that I originally sourced.

Television documentary: Episode ov Australian Story ABC shown in 2007

I missed the start ov the episode and was ov no specific purpose in the viewing. The story however did capture my attention- the near Kempsey location; the year 1990 been the year Evelyn disappeared aged four; the mother been aboriginal and no mention ov the male parent. There was as well a deceptive (deliberate?) conclude ov the story showing a plague with the name Craig.

Learnt:

- The names ov the three victims.
- Police Minister of 2007 was David Campbell.
- Police were not necessarily proceeding in the consideration that there was only one person responsible.
- A original reward ov \$100,000 for leads to a conviction was only for Colleen Walker's death.
- Colleen Walker was the first to disappear on September 13th 1990 aged 16.
- Colleen Walkers weighted down clothes were dredged 500 metres downstream from Congarinni Bridge over Taylors Arm.
- Colleen Walkers body has not been found.
- Evelyn Greenup disappeared from her home on October 4th 1990.
- Evelyn's remains were found in bushland six months later.
- Clinton -Speedy- Duroux aged 16 disappeared on February 1 1991.
- Clintons remains were found in bushland weeks later.
- A local named Jay Thomas Hart was charged with Clinton's death in 1994 but was acquitted.
- The same man was charged with Evelyn's death but acquitted after trial in 2006.
- Clinton had a brother named Marbuck Duroux and his partner was a Leonie Wilmshurst.
- Detective Gary Jubelin has committed ten years to the case.
- A reward of \$250,000 was put forward for information to any ov the three deaths.

Title: To catch a killer

Learnt:

- Cemetery Road was renamed Gumbaynggir Road after the original people with a adjunct road named Congarinni Road.
- Housing is not Department of Housing but Aboriginal Mission Housing.
- Bowraville is lorded over by the Catholic Church.

- Evelyn had a favourite pair of pink shoes.
- On October 3 1990 Evelyn's mother Rebecca Stadhams hosted a alcohol fuelled party at her home Number 6 Cemetery Road Bowraville.
- Evelyn had a aunt named Michelle Stadhams age 41.
- Evelyn had two brothers Aaron aged three and another brother named Aden.
- Evelyn had a sister named Lytiah Stadhams.
- Evelyn had a Nanna named Patricia Stadhams
- Evelyn's remains found along Cemetery Road approximately four kilometres from town. With Evelyn's remains was one ov her pink shoes with the other been found in the garden ov her home the morning after she went missing.

- Evidence was provided to a Coroners Court that accused Hart ov abducting Colleen Walker from near No3 Cemetery Road and four months later while Clinton was staying at No3; Hart invited Clinton and his girlfriend to spend the night at his house. Of the next morning Clinton's girlfriend awoke and Clinton had gone.

- In 2006 Hart was acquitted ov Evelyn's death in a Port Macquarie Court mainly as a result of discreditable evidence that some persons believed they had seen Evelyn in the days after she went missing.

- Detective Jubelin provided a 70 page submission to DPP Nicholas Cowdery QC. In June 2007 Cowdery rejected the application. The victim's families obtained that submission and they presented it to the Law Clearing House who then presented it to a QC who was positive regarding the submission. Under Pro Bono provisions Allens Arthur and Robinson sent a representative/lawyer Brendan Ferguson to Bowraville. In March 2010 Allens Arthur and Robinson presented its submission to Attorney General John Hatzistergos for a ruling under the new double jeopardy legislation. October 2010 the Attorney Generals office had yet to make a decision.

- **Leonie Wilmshurst** in reference to the three cases been referred to a large legal firm- “people are taking us seriously at last.”
 - **Detective Jubelin** – “I want the person or persons responsible for these crimes to know we will never give up.”
 - **Michelle Stadhams** in context of Evelyn – “She was a gentle sweet thing she would never have gone of with anyone. She just loved her brother Aaron and they were constantly together.”
 - **Michelle Stadhams** – “The first police just asked us straight questions and that was it, they didn’t get to know the families and the dynamics in the community and about us and how we live our lives.”
 - **Michelle Stadhams** in context of Detectives Jubelin and Evers – “they got to know us all and they have been on the ball”.
 - The locals had no trust with the original police inquiry.
 - The accused Hart was known as a perve hitting on women and often caught inside their homes in the middle of the night looking for unwanted sex. That he was known to be violent when spurned; he was known to have drugged woman to get his way with them.
 - Hart has a new name and a partner with whom he has had a child.
 - Former State Coroner John Abernathy listed eleven striking similarities about each ov the cases all of them leading back to Hart.
 - Strikeforce **ANCUD** was set up in 1996 to re-investigate all three deaths.
 - Colleen Walkers mothers’ name – Muriel Craig. Age 55.
 - **Muriel** in context of Colleen –“She had a lovely personality and me and her were really close. Her spirit is still with me. It makes it easier.”
 - Colleens photo shows her wearing a necklace.
 - Clintons remains found approximately seven kilometres along Gumbaynggir Road.
 - Clintons photo shows him wearing a sloppy joe with some type of spirit face symbol that looks alike to a moon demon.
 - Clintons fathers’ photo shows him wearing a cap with a satanic style symbol.
 - Clintons fathers’ photo shows him wearing a Holden t-shirt with the symbol of the lions paw on the sun.

PART 6: MY UNDERSTANDING OV ALL THREE DEATHS FROM OWN INVESTIGATION

- Went to Bowraville on 16th October 2007.
- Went to Police Station which was unattended. A policeman's wife came from the adjoining residence and upon informing my purpose she opened the station so to take my details.
- I was informed that Officers Jubelin and Evers were no longer ov the station and that Jason Evers was at Ballina station.
- I was warned not to approach member's ov the aboriginal community in subject ov the murders.
- At the police station a member of the public entered. That person's inquiry was to inform that he had found along the side ov a road a box full of needles ov alike to that ov which a vet would use. He mentioned that it looked like the box had been there for a long time. The woman attending took the details ov location and informed that she would send some officers out to collect them.
- The Aboriginal Land Council Office is on the main road ov Bowraville township.

- (The date 16th ov October was only twelve days after the anniversary ov Evelyn's disappearance and was ov the same year that the deaths resurfaced on national television along with a newspaper article in April 2007.)
When walking past the Land Council Office there was a engulfed buzz ov scandal and excitement in the eather. It was fully throughout the doors opening. In my certainty it was a eather ov some very hot topic going on. I distinctly recall one aboriginal adolescent male ov approximately 16-17 years ov age. He was sitting in quiet yet alive listening with another person. It was very obvious their topic was ov that eather.
- Upon locating Evelyn's grave at Bowraville cemetery I was ataken to see a totally different grave site to that shown in Australian Story. Evelyn had a middle name of Clarine. There was a photo ov Evelyn which in objective viewing identified Evelyn to have been a child ov premature birth. The grave had recently not been tendered to and there were lots ov toy trinkets.
- I learnt via the taxi driver in the return to Nambucca that there was a indigenous rugby league tournament in Macksville on a weekend around the 4th.
- The driver said Evelyn was taken from her bed and that her grandparents were still not over the loss. He also spoke of a family feud between the Greenup's and another aboriginal family that resulted in a murder of a uncle only a few years prior.

Needed Known: The Pope while in Australia for the WYD declared in English a proclamation that the Great Southern Land belongs under the domain ov The Holy Spirit in the cared authority ov The Holy Roman Catholic Church and there thus he The Pope.

Tangible relevance to the death of Evelyn Greenup: If it is fact that fore say I was Aden's male parent and that truth was learnt by the 'lordin catholic church' it would be ov certainty that such information would have reached as far as the Vatican. If it be that Hart is a zealot Catholic and is affiliated in any way with the Harts ov the Melbourne Catholic Diocese the relevance of subjecting the Catholic Church in this Detail becomes obvious.

It would be ludicrous to consider the Catholic Church not been ov the 'again' mentality that is referred in **PART 10** and **PART 12**.

PART 8: EVELYN GREENUP

Clearly by the photo on her grave and the photo in the 07 newspaper Evelyn was growing rapidly. Evelyn in thus and from the photos was a very well cared and well clothed child. In thus Evelyn must have been fundamentally loved. The 07 newspaper photo however does take me into the perception that Evelyn had deep trepidation in her person, perhaps fearful of someone standing off camera, someone of authority. In my perception, the way Evelyn was entwining her fingers disclosed a deep self and believer of God/Allah.

It is generally recognised that small town aboriginal communities that have a social fabric of high alcohol use gather in large family groups in a house premise. In that socializing a male dominance when fuelled by alcohol often extends into violence against women. If it was that Hart entered the bedroom to commit a sexual act against Rebecca and it was that Rebecca was drunkenly asleep or in drugged stupor or both; it would have been highly certain that Rebecca was already laying down. If this be the fact of the moment Hart would in all likely have been deliberate and quiet; it would not have been a loud/violent physical act. While it was that Evelyn was only four years old I am very doubtful that the 4th of October 1990 was the first time Evelyn had witnessed an instance of physical or verbal violation. I am very doubtful that Evelyn would have been a child that would have gone into a hysteria of screams just because she saw a man attempting to get into bed with her mother (as was purported in the October 2010 article). I presently believe that on the night of the 4th the purported screams from Evelyn were at no time in concern for the well being of her mother but screams totally under the fear and actual of a man taking her away.

* From my encounter with Rebecca-; Rebecca was sober at 5am with no evidence of any substance use. I find it unlikely that Rebecca would have been blind drunk and thus awakened the morning of the 5th hungover.

My understanding is that Hart for twenty years since has been a person not known to have attempted any other approaches towards children for sexual gratification and that prior to October 4 1990 not known to be sexually interested in minors.

I believe: Harts pre-meditated objective on the 4th was to take Evelyn in the singular objective so to sacrifice Evelyn either in own decision or under instruction with the later I believe to be more probable.

Very Important: Yourselves upon reading **PART 7** must understand there has been since my birth a very intense and continuous regard towards me by the Catholic Church; high profile persons ov the Australian Aboriginal People and Australian and World Governments. If Evelyn was baptized into the Catholic religion and then learned that I was fore say Aden's male parent it would be distinctly possible Evelyn picked up talk ov spiritual deliberations concerning myself. Ov hearing such her spirituality may have becomed believed in me not Jesus Christ; Catholicism or Aboriginal ancestry. This may have triggered internal spiritual chaos within the Nambucca Aboriginal Community. (This hypothesis also becomes relevant with the murder ov Colleen.) If it be that Hart is a extreme Catholic perhaps a hater ov me and/or Hart's King is a believer in King Bobby or King Boney particular issues become significantly relevant:

The apostement scandal becomes tangible when the death ov Evelyn Greenup is deliberated as been a sacrifice with affiliated Christian connections. Relevance becomes tangible with the NSW Parliament when issues in due processes ov prosecution are questioned.

* President Obama "He's free". This was aired on 2GB during Obama's visit too Australia.

PART 10: NSW PARLIAMENT AND NSW COURTS

I have serious concern regarding a variety of dominant persons within the NSW Parliament and Courts.

- I allege that there are members of the Queens Council that are ill in the beliefs as wrote of in **PART 11**. That the hierarchical believe that systematical change such as a change of name to the State shall cause climatic change.
- Reverend Fred Nile is in the minimum of a profile, a zealot of Christian belief. It has been said that Nile has declared himself as God Almighty by stating that he is 'One'.
- Morris Iemma is a catholic who was almost puppy like in his greeting of the Pope.
- Morris Iemma was replaced by Christine Keneally who is a extreme believer in the Catholic faith.
- Former Attorney General John Hatzistergos is of Greek origin and is relevant to the apostement scandal.
- I believe Nicholas Cowdery is a staunch catholic.
- There is apparently a very fundamentalist Christian body of parliamentary affiliates.
- Premier O'Farrell in his first twelve months continuing in the conservative ill propaganda of unnecessarily and non contextually using "again" in practically every statement that he speaks on radio and television.
- John Robinson declaring himself a believer in climate change alike to the prophecies of Al Gore. I allege Robinson believes mortal persons are capable of causing earthquakes and can move planets etc.
- Pat O'Shane new permanent head of The NSW Department of Aboriginal Affairs 1982.

Consider:

The submission for a new trial against Hart has had the reality of a change in governments. It is now fourteen months since that change of government. When Evelyn Greenup's death is reviewed as been a sacrifice with possible ulterior connections right through to The Vatican and The Australian Commonwealth Parliament; initial court dates; reopening dates from authorities; reward date announcements may create a data sheet that would give increased ground to a ulterior sacrifice scenario.

News at Five; Channel Ten: Story covering the airport bikie bashing. In a obvious Channel Ten and person of interest (poi) collaboration; the poi, a large woman walks in urgency towards camera wearing the colour green. There was no context of the poi in the coverage. The poi did not look bikie gang connected. (I presently am unable to provide a date of this coverage.)

April 10 2012: NSW Court sentences the head of a bike gang to twenty one and a half years jail for the bashing murder at Sydney Airport in August 2009. April 2012 is twenty one and a half years since Evelyn was abducted. The sentence length does not seem to make rational logic in either a twenty year sentence or a twenty five year sentence with time already served.

The coincidental of number incorporating with actual events and linking them with my reality; went long ago from been just coincidental. Of like- Evelyn Greenup's actual in a connection to my actual I am certain is occurring.

- Unsure of the broadcast region of radio station 2BS and relevance with the second of the Gumbaynggir Kings the coastal king; King Boney (2BS -Too Boney's Sun).
- There was a prominent story of same day concerning the mining magnate Tinkler who I consider is of some type of aboriginal descent. That story was of Tinkler reneging out of monetary support for the A-League team the Newcastle Jets.
- That the coverage of the boy's wellbeing seemed to be abruptly halted by the radio networks and while I don't listen to the radio continuously there was no story concerning the boy's disappearance on the eleventh or there after.
- That Detective Sergeant Lance Chaffey of Newcastle was of the first officers involved in Evelyn's disappearance.
- That the boy's disappearance is near the anniversary date of Clintons and Evelyn's remains been found.

12th April 2012: ABC News Radio- Western Sydney story of coroner's inquiry into the disappearance of a twenty month girl from her bedroom on November 10 2005. In the story the coroner was questioning the father of his calmness in the telephone call to report his daughter missing. ABC played some of the call. The father sounded aboriginal in his tone and word choice. The issue is that the father or the family name is very Islamic. Name: The El-Dennaoui's.

PART 18-40; 41; 42: (18-40) is a front page of the Daily Telegraph 27th April 2012 (Evelyn's remains found anniversary date). The continuing story on page two informed that a person overheard words that a child was murdered by her father and buried on a farm property. **(18-41)** reports that a religious teacher in Lebanon the El-Dennaoui's community in Sydney asking about a disappearance of a girl child on the ninth. The photo of **(18-42)** hardly does well towards the El-Dennaoui's when suggestions of a sacrifice are considered.

* In Federal Labor rectric particularly ov the late 80's and 90's the mantra ov been a 'true believer' was rampant. Kim Beazley was a big time self promoter ov been one of the 'true believers'. Fundamental Judaism is wrathed in the acts ov sacrifice in particular infants. There was a parliamentary sitting ov the early/mid nineties that was in a time when a Israeli Prime Ministers funeral was announced. To grasp an understanding of the spiritual belief/ the ulterior regard held towards Judaism it is important to view the pandemonium want ov the parliamentarians to attend that funeral. Kim Beazley was very prominent in this action.

From many observations ov Kim Beazley via media footage in Labor party groupings it was obvious that Kim Beazley had a mad mentality regarding the stars ov the universe and in particular The Southern Cross. He was known to be ov saying - if they fall have them fall on us- in a context ov the stars been spiritually taken from the sky. PM Howard after versing the Lords prayer with a barrel chest, looked in a somewhat surprised queried way at a worded page and reads - "Evil has no religion"-.

PM Howard then placed that written statement down and went into September 11 rectric.

Opposition Leader Dr Brendan Nelson: "Israel is the home ov the human spirit"

PM Rudd: Part of his media propaganda was to always be seen at least once a week coming out ov a church service.

PM Rudd: In his defeat declaration PM Rudd shunted the dais he was standing before in a gesture ov to cause a earthquake.

PM Gillard in context ov the Old floods: "a global mayor".

PM Gillard was referencing a regional Queensland mayor ill in mortal reality; that he be a mayor who can change the direction of a cyclone simply by swivelling in his mayoral chair. Her tone implied she as well was a believer ov such capacity.

Supplementary 11A:

Old Premier Bligh in context of the anniversary of the Old floods: “it was a test” Premier Bligh was implying that the floods were of biblical wrath and a test of the people’s worth.

John Login ABC News presenter 702 ABC: “ssshhhhh”

This was contexted after the news segment for the one year anniversary of the New Zealand earthquake implying that the earthquake was the cause of a devilish mortal act.

Coincidences?

- 1990 was a Hawke Labor Government.
- Political and media intensity both direct and sub regarding Evelyn Greenup re-begins under a labor government both State and Commonwealth.
- 12th July 2009: Channel Nine 10:13 am Harvey Norman ad promoting sale of 17inch laptops for \$1866. The computer screen was done in green.
- 2011> SCG Aust-v- India> Jane McGrath Day. PM Gillard wears pink shoes. (I recognise that pink is the colour for McGrath Day). I suggest it would be worth reviewing any footage of Gillard at the game to analyse her words in speak.
- 2012> Australia Day Riot (aboriginal riot) Canberra> While being ushered out by security PM Gillard lost one of her shoes.
- Minister for Aboriginal Affairs born in 1942. (42 is a heavenly regarded number)
- ABC Radio Canberra is signalled in 666.
- The Popes staff is covered in the symbolism of 666.
- PJ Greenup’s telephone number is 6566 5666.
- Bowraville Land Councils address is Number 66.
- AAR’s telephone number is 9230 4966

2nd April 2012: 2GB and ABC news radio inform that the Dow Jones finished up 66 points there thus final trade in March finished up 66 points. The ASX followed by closing down 4 to 4,416. (Evelyn’s age at death 4; Clinton’s and Colleen’s age at death 16).

2nd April 2012: 2GB— Alan Jones interviews a Anglican Priest from Dulwich Hill who to raise \$10,000 went 120 consecutive rounds of boxing against 66 opponents one of whom was Anthony Mundine.

16th April 2012: Channel Seven 11:30 News approx 11:45am. This ad has been on for a number of years that of Insurance Company that promotes with a old fashion green telephone. It’s ABN has 666 in it.

27th April 2012 :(anniversary ov Evelyn's skull been found.)

2GB Ross Greenwood states that a 1% shift in GDP equals 6.6 billion dollars.

29th April 2012: 2GB- Parramatta –v- West Tigers

West Tigers 19-0 halftime – went to 31-0. Then in the 66th minute Parramatta scored. 31-4. (Me 31 in 1991). In the summary ov the game Andrew Moore (2GB) – “Parramatta scored 30 points in the last four and half minutes”. This was blatantly said and certainly very incorrect. In the after match interview West Tiger's Robbie Farah “thank Christ” Ov this interview the eather was full ov were a fraud.

Needed known: In the NRL 2009 pre-season promotion song was a chorus ov –

“Wake up Craig now”.

8th May 2012: ABC Radio – Host Shaun Walker: Reporting about a study conducted by King's College England on brain differences ov psychopaths. The number ov men studied was 66.

Month ov April 2012: Coles Engadine- Nerada Tea Bags fifty pack. Save 66 cents.

(I have in the last two years shopped at Coles Engadine. I regularly purchase Nerada tea. Coles in their supermarket leitmotifs have for many years exploited me in ridicule and belittlement. I have no doubt that my shopping docketts are exploitedly examined for ill numerical lunacy. I have no doubt the 66 cent reduction and the fact it was done in the month ov April is tangented with Evelyn; 66 High Street and me.

27th April 2012: ABC Radio. A Victorian Court sentences a forty two year old man to eighteen years jail with a minimum sentence ov fourteen years for the deaths ov 10 persons as a result ov deliberately lighting one ov the fires in the Victorian 2009 bushfires. – The minimum sentence takes the man to age 66. In the description ov the Court verdict the ABC journalist finished in a sort ov registered tone- “it may not be as high as some people believe”-.

Journalist correctness in context would be: ‘it may not be as long as some people wanted’-.

* It is to be reminded that media both commercial and government at one stage gave the death toll as been 210. (too 2010). They then revised this total back to 173 which equals 37 less. That is the football number ov Adam Goodes and Jim Steyne.

* I have always and remain suspected the death toll to be very false and deliberately false. I fed this allegation into the intellectual independent circle ov Melbourne in early March 2012. I believe that the actual death toll is approximately thirty.

* If the recent five injured soldiers were in fact killed the death toll ov Australian soldiers in Afghanistan would be 37. I was thirty seven when they invaded Afghanistan. I remind that all since September 11 in concern ov hostilities and invasions has been jihadist warfare (a holy war- a spiritual war). I remind ov the example given in NOW- “he's our Allah.”

On 24th November 2011 I went to Sutherland Library to do research on the Gunbayann People. The Gunbayaan People had two kings they been King Bobby and King Boney. King Bobby was king ov the inland grouping and King Boney king ov the coastal grouping.

Same night: 1AM ABC radio news -

Chris Bowen Immigration Minister- “**as a result ov Bobby’s addiction to lying**”.

Same night: 2AM ABC radio news -

Chris Bowen Immigration Minister- “**as a result ov Bobby’s addiction to lying**”.

No further news hours repeated this quote.

It can be only regarded as objectively correct that there is no possible connection ov this statement by the Immigration Minister to the issue ov the asylum boat people and issues ov process.

I allege: The Minister is a politically sick man and that the quote was very deliberate in total context reference to Evelyn Greenup been sacrificed. I state that the minister’s quote be broken down into a triple sub context with:

-Bobby- been in reference to King Bobby and thus revealing knowledge in concern ov Evelyn’s sacrifice.

-addiction- referencing to my vocation of gambling ov which the government is desperately wanting to label me a ‘problem gambler’.

-lieing- is admitting that he himself and the government are chronically and irreversibly ill in their lieing to the Australian people.

***The statement by the Immigration Minister compulses myself into extremely serious questions of government knowledge both State and Commonwealth. Knowledge pre and post regarding all three deaths must be investigated. Strikeforce ANCUD must talk through with me. My immediate recommendation is that a approach to The Commonwealth Minister for Aboriginal Affairs in 1990 Gerrard (Gerry) Leslie Hand is where to begin.**

It was understood at ACT street level in the eighties and nineties that a large source of cannabis was from the Kempsey region. If it be that Rebecca was indeed the largest Aboriginal female of my informed interlude perhaps she was a regular transit person into the Belconnen and Canberra areas in those years. When I first became known of Evelyn (2007) and as explained went into a belief that Evelyn was my daughter; in my thinking remained a prominent public service person a Mr Ken Henry. Mr Henry was the principle taxation advisor for the Rudd and Gillard governments before very recently retiring. (Presently working with NAB.) I am unknowing of anything else regarding Mr Henry except I consider that he is of aboriginal.

The reason Mr Henry remained in my conscious was that within the photo of Evelyn at age four I remained seeing a distinct resemblance to Mr Henry.

- Perhaps Mr Henry in his unknown 1980 years had a interlude with Rebecca.
 - Perhaps Mr Henry knows more and all about Evelyn Greenup.
 - PM Gillard in rectoring the retirement of Mr Henry defined Mr Henry as "One of The Greats."
 - Perhaps if Rebecca was a transit person connected with the cannabis trade there may/may have been fearful cause for Rebecca to lie and fabricate stories.

PART 12: Allens Arthur and Robinson (AAR)

Newspaper October 2nd 2010. Chris Fogarty “This case deserves wider attention.”
I first spoke to this law firm regarding Evelyn Greenup in three telephone calls on 2nd November 2011. I telephoned a fourth time on Friday 4th November and was put through to a Melanie Hunt assistant to Chris Fogarty. In that telephone call I gave extensive detail ov whom that I believed I was regarding Evelyn. Melanie’s response was very attentive and understandably non committal. I informed that I believed it correct that a broader understanding ov who that I am needed to be understood. It was agreed for me to deliver a document that would achieve such (**NOW**) to their office on Monday at 9AM and to then telephone that afternoon. Ov Monday’s telephone call, Melanie informed that she did not open the envelope despite it been addressed to her; instead handing it directly to the firms Executives. Melanie then informed that she was instructed to provide no further information. I asked if there was a conflict ov interest (as my call on the 4th, mentioned the media issues ov exploitation regarding Evelyn). Melanie explained that she was not a lawyer only a assistant and that no specific reason was given except that she was told that the contents within the envelope had no relevance to the case.

I regard: The Executives at AAR appallingly handled my inquiry.

I allege: AAR regard themselves as global in the same mentality as the Qld global mayor.

I am: extremely questioned towards AAR’s sincerity to achieve justice.

- AAR self admits that it does not normally involve itself in murder trials.
- AAR was given the case under a pro-bono instruction by a NSW Labor government governed by Christine Keneally; a NSW government that new it was bound for imminent election defeat.
- AAR’s telephone number is 9230 4966.
- AAR’S office is in the Deutsche building.

PART 13: 2GB

It is important to comprehend that elite radio stations/television stations program their segments to the very second. Success at this is held as testament to the professionalism of that network.

In 2011 and 2012 Ray Hadlee in his preamble for his daily program promoted 2GB as a member of the Southern Cross Group. 2GB also promotes itself as a member of the Macquarie Group.

This radio station has an obsessive pursuit in anything and everything regarding myself; feeding itself with and from 'U.S' propaganda of naming me as 'Mr B'. I have no sure explanation of this and nothing in my actual past relates to such a nickname. I have suspicion there is some type of fable connection with a living person from the forties or fifties, some reincarnation belief.

2GB are very *U.S All The Way* agendered; very national agendered. John Singleton is a major add man of the Australian television networks and a owner of 2GB.

2GB are madly believed in ideology beliefs that I exemplified in **PART 11**.

2GB conducts a labyrinth of derogatory and exploitive sub contexted sections in its propaganda that has reference to myself. A recent example of this has been their lead music chorus when going into their hourly news coverage-

“Craig’s gone inane; leaking boats; the worlds gone mad,,,,,,,,,”

Within their propaganda beliefs and nationalist agenda 2GB have been wilfully conducting exploitation in the death of Evelyn Greenup.

Example:

2GB conducts hourly news. In seventy five percent of instances they give the interbreak time as “four and a half past” with most of the other twenty five percent been “four past”. The extent and almost total confirmation of exploitation in this example I recognise loses footing if it is that Evelyn was not age four and half when she was murdered or of the date her body was found and or was in fact not four and a half months premature.

3rd November 2011: Sydney Live Ben Fordham

Traffic report – **“Evelyn Street”** instead of Eveleigh Street.

3rd November 2011: Money Show Ross Greenwood

Interview with Mining Magnate Andrew Forrest. Interview was in context of the mining tax – Andrew Forrest **“Evelyn knows”** instead of everyone knows.

(On 4th April 2012 Alan Jones interviews Andrew Forrest.

Main topic was mining tax and Forrests' iron ore mine in W.A. . It was informed that the mine begun development in October 2011 and completion due in October 2012.

A forecast for the mines revenue production was \$155 million.

(This forecast would have been made in 2010. Muriel Craig 55 in 2010).

Andrew Forrest - **“it's gonna have to come from the genius”** said twice.

Andrew Forrest - **“My heart greaves”**. (Bowraville Newsagent Mal Greaves)

These quotes and the entirety of the interview, Forrest was very double context and sub dismayed towards 2GB. To use the verbage “greaves” to describe his emotions concerning the debate over the mining tax is extreme emotion to say the least.

Alan Jones too the listening audience and after closing out from talking to Forrest **“Make of it what you will”**.)

13D – Was the mines starting date 4th October 2011?

4th November 2011: Money Show Ross Greenwood

In the beginning of the program Ross Greenwood's first words and in absolutely know context of any issue- **“I'm so very sorry.”**

I allege: Ross Greenwood was in context reference to my telephone call to AAR made on the 2nd.

How? Either AAR records all incoming calls and shared my telephone call with Ross Greenwood or the telephone I was using was bugged.

10th November 2011: Chris Smith program

Chris Smith in interview with a member of the Moody Blues who spoke of- **“Doveux Universal Orchestra.”**

25th November 2011: Money Show Ross Greenwood

Greenwood in the lead after the 7pm news “**a cross Australia**” then went into welcoming affiliated radio stations. Greenwood named about six stations all of them with a radio code of 4. Greenwood finished with radio station “**2BS**”.

(2SER on 2nd April 2012 approximately 6:10pm informed that they had a affiliate station near Taree named “**2 BOB**”).

Allege: Greenwood was very deliberate in his choice of stations so they all contained the number 4. The sub of 2BS is – Too Bobby’s Sun-.

Question:

13E- Was it six stations code named?

28th December 2011: Weekend program with Warren Moore.

2:55pm (Too 55? - Murial Craig aged 55 in 2010)

In context of answering calls for a competition that had a correct answer of 8; the first caller got the answer incredulously wrong- Warren Moore” **you’re..... from 2BS?”**.

14th January 2012: 2GB were regularly using commentary extracts from channel nine in their news during the Australia –v- India Test Series. In this instance the extract was of Mike Hussey been caught for 14. Commentator Michael Slater- **“Aaron’s gone”**.

Issue – There is no Aaron in either side and no umpires named Aaron. There is no Aaron amongst the commentary team and no Aaron at 2GB.

2nd February 2012: 10 AM News

News presenter Erin Maher reading story of flood waters rising around the Macksville area. In no context of content – **“heard screaming in the morning.”**

(Erin Maher is the news director of 2GB.)

12th April 2012: Warren Moore- The Afternoon Show:

Warren Moore gives time as **“3 minutes to 2”**.

In the next hour of which I only fully listened to the last five minutes Warren Moore was repeatedly saying sacrifice in some type of competition contest. The correct answer had three choices. Warren Moore then gives time as **“3 to 4”** when it was only approaching the hour of 3pm.

24th April 2012: Chris Smith program

Chris Smith at 2.57pm **“celebrate the sacrifice”**

This said in the supposed context of Anzac Day.

25th April 2012: 4pm

2GB’s coverage of the NRL game. In the promo lead, the very first word was

–SACRIFICE-

2GB then went into a theme song for the game with no return context to the word sacrifice.

PART 14: MEDIA EXPLOITATION OV EVELYN GREENUPS DEATH

29th June 2006: Channel Seven 6pm News

Ian Ross (newsreader) wears green tie. There was a story ov a rooster's player charged with punching a woman. The scene showed a large woman wearing a green top. Next scene showed a rooster's player going to training holding a green drink bottle. In either the Channel Seven or Channel Nine 6pm News there was a story showing Kevin Rudd and Dr Brendon Nelson at a day school with a girl child ov age four. Dr Nelson holds a play size green plate. Ov the same story there was a section showing Malcolm Turnbull and Joe Hockey behind them was horizontal line in the colour green.

8th August 2007: Channel Nine- *Fresh*- (cooking show)

At 11:42. A Woman's Weekly promo ad. The promo showed a page from the magazine with a giveaway title ov - Free Crabtree and Evelyn Giveaway-.

Approximately 10th June 2008 (a Thursday) Channel Seven 4:30 News

Harry Kewell in Dublin in a world cup qualifier interview.

Harry Kewell looking to the camera and in no context – “Craig love your daughter”

* I have no knowing ov having a daughter.

8th July 2008: Channel Ten 5pm News– A story from America that was contexted as been in subject ov child obesity. The scene showed a girl that looked about four year's ov age on a hospital bed with Doctor Craig Sable.

Issue: The child was in no way obese.

Allege: This was deliberate and in a type ov dyslexic sub context ov Evelyn and Rebecca in her current obese state ov physical.

1st November 2008: Channel Ten –Sports Tonight

Presenter Rob Canning – “Scenes ov sacrifice”. This was with footage ov the Indian cricketer Kumble dropping a catch and hurting his finger.

* In April 2009 the colour green was extremely co-ordinated in both the domestic and U.S. television networks. The following are only a few examples ov such. Ov late June through too early/ mid July 2009 the colour green collaboration re-begun.

Question:

14A – Is there any Evelyn Greenup data that is ov late June to early/mid July including conception date?

A –

20th April 2009: ABC Lateline

Bob Deebus wears a green tie with red stipes. The normal Lateline studio backdrop was redone in the colour green.

25 June 2009: Hong Kong News SBS

The colour green was in all its stories. One story was ov a pre school showing a classroom desk with green blocks. On the blocks were the letters B&C done in a dyslexic manner.

26th June 2009: Channel Ten Morning News

Twice it showed a segment of the Sydney Swans at training. The scene showed the team standing in a huddle. Paul Roos (staunch Catholic-very U.S.) was standing back to the camera. The camera was at Roos's right. The aboriginal player Michael O'Loughlin was opposite. It was very obvious next was a coordinated scene in collaboration with the cameraman. On cue O'Loughlin raises his head; just his head into the camera shot and looks at Roos's. There was no team laughter only quizzical looks. It can only be interrupted this was a serious moment and the gesture I allege was in context and referencing Evelyn Greenup. That is all that was shown.

28th June 2009: Sunrise Program Channel Seven

There was a script scroll for a mobile phone story – *Mobiles for 4 year olds*- The main scene showed a four year old girl using a mobile and saying something like 'you're my Allah'. Then they gave the mobile phone data which was for 5 year olds to fifty year olds.

In the return back to the studio Melissa Doyle: "four year olds should be left alone". Upon saying this she went into boisterous laughter. The rest of the Sunrise presentation hosts laughed along in nervous shocked look at Melissa Doyle.

7th July 2009: Channel Seven Lipstick Jungle

This episode had a scene with one of the leading actors getting a return mail package containing baby clothing. She pulls out the baby clothing which is green.

8th July 2009: Channel Ten 4:30pm Friends rpt episode.

This episode was in the middle of a sequence story of Jennifer Aniston having a baby girl. This episode has the baby in the arms of the other actress Cox. The baby is in all white clothes with a green collar just showing under all the clothing. The blonde actress in the scene when walking out of the room speaks "it takes between six and eight months." This had no context.

8th July 2009: Bold and The Beautiful Channel Ten

Had a café scene where all the waiters wear the colour green. The café scenes continued for a number of weeks. The café is/was and has not been a regular scene.

8th July 2009: D.W. SBS

Host Melinda Crane wears green. Shows a factory floor machine on wheels with a number 4 on it.

9th July 2009: U.S Morning Show Channel Nine 4am

The Negro female host wears green. She is in a scene with a child's play set of cups blue in colour and a green straw.

14th July 2009: Channel Seven Lipstick Jungle (11:30pm)

Telephone porn ads in commercial break. One of the girl's code was VI4 done in green. I allege: VI4 decoded is Very Important 4 year old.

29th July 2009: SBS French News – the news presenter was female and new. She conducted a studio interview with a woman whose name was Evelyn. The backdrop colour in the studio was green. With the speaker being in French I did not gather the subject context. It was however at the end of the interview the next scene began in a deliberate way of having the viewer focus on the computer logo name –SUN-. There was no continuance and the news program simply continued into the next story.

4th October 2009: Channel Nine

Rugby League Grand Final Melbourne -v- Parramatta

Prelim game. Commentator Andrew Voss made emphasis on number four in a game call yet the number four was in no reality in that part of the game.

Main game. In the game's first set of six a Parramatta player takes the ball forward. Commentator Ray Warren – “Laurie (the Parramatta player) offers himself like a sacrificial lamb”

16th minute mark of main game: Melbourne brings on an interchange player with No 16 on his jersey. (In recollection I am certain the player deliberately holds his number card upside down.)

6th October 2009: China News SBS (6:38 AM) - (4th October in China)

A story showing a suburban street in Beijing. A number 4 was plated on the screen followed by children that were of the age of four years playing.

A voiceover of a girl child “Craig”.

16th February 2010: Channel Nine 11.25am

A ACA promo for that night's episode. In one section they showed in an illusionary way (through the glass of a sliding door) two coffin child size boxes on a living room table. The coffins were in green. In the actual program hosted by Tracey Grimshaw who began in a type of quizzical look with an obvious retrospect to the promo; those two green boxes were very small (skull size) and on a coffee table.

15th December 2010: Channel Nine- 3rd Test Aust-v- Pakistan Day 2

In the afternoon or tea session there was a scene showing the Australian dressing room.

This was done looking through a double glazed window. The scene showed Ricky Ponting on a massage table. The emphasis was on his right hip. Channel Nine plated over the scene the letters ECS.

I allege: ECS stood for- Evelyn's Craig's Sun-.

28th March 2011: Channel Seven 11:30 News

An ad promo for Sevens Australian Homicide show. The theme of that week was of three unsolved murders.

* It was in April 2012 that radio news stories (inclusive of ABC) in all fields of subject co-ordinated with the number 3. It was/became very obvious this was being done deliberately. I confidently assert that in this time period there was of a minimum sixty news stories that deliberately storied around the number 3; stories both local and U.S. international. The saturated co-ordinated use of the number 3 eased at the end of April. The following are just a few examples given to show the diverseness of this collaboration.

4th April 2012: 2GB 5pm News

Report ov 3 day game between Australia and West Indies Board Eleven. Australia required 86 more runs to win (Evelyn born 1986). Stumps Day 2. Australia 0-30 needing fifty six more runs to win. - Australia won losing 2 wickets in the 56 run chase there thus Australia won by 8 wickets. (Muriel Craig 56 in 2012).

7th April 2012: Ron Dufficy Sky Racing: “He’s better at three”. This had no context in the discussion Dufficy was ov.

April 2012 - Australia –v- West Indies First Test. Australians drop three catches in the first innings. Needing 191 for victory Australia wins by 3 wickets.

12th April 2012: ABC News Radio

Professor Bob Gregory ANU – Context ov Reserve Bank interest rate decision. “Debate is still ongoing between these three groups”.

12th April 2012: 2GB. Presenter Warren Moore

“3 minutes to 2” First caller after the 2pm news referenced the number 3.

12th April 2012: ABC Radio

“3 people charged with depraved sexual acts against their own children”

12th April 2012: ABC Radio. Presenter Shaun Walker

“3 stage rocket” Context ov North Korea’s impending rocket launch.

13th April 2012: ABC News Radio approximately 7:13am.

Senator Chris Evans- “3 qualifications”

Context ov training courses for people unemployed.

16th April 2012: NHK News (Japanese news)

Story showing Japanese ministry ov defence spokesperson talking in context ov North Korea rocket launch. There was a backdrop that showed the letters - **F**

E

That was all that was shown. They then went into coverage from North Korea that showed the rocket at launch with the number 3 on it. Then there was a missile shown in one of North Korea’s military parades. The number on the missile was: 9010 20 212

April 2012 -unemployment rate drops .3%.

16th April 2012: promo ov the Sunrise Program during the 11:30 am news. Melissa Doyle wears a pink top.

Question:

14B- Why? Why did the media, not just the domestic media but ‘world news’ so deliberately co-ordinate the number 3 in its news stories for April?

A- From the day of Evelyn’s abduction there has been deliberate acts to cause confusion and deception to prevent facts and truth been revealed while at the same time subliminally grossly exploit and reveal the actual of the 3 Bowraville deaths. The examples of exploiting the life and death of Evelyn Greenup presented in this Detail confirm that tangible affiliates within the media both domestic and world have conducted such actions. The use of the number 3 in the month of April 2012 I am absolutely certain was totally done in sub-context of the three sacrifices of Evelyn; Colleen and Clinton. I allege in extreme certainty the extent of the co-ordinated use of the number 3 was done in a purpose so to create sub listener confusion in story presentation.

Easter Friday 2012: 702 ABC Radio – News Reader Jackie Maher
Story of Australian Christian leader talking of want for the leaders within the Australian Parliament to think long term. In the middle of him talking ABC went into a voice over: “her remains have now been collected”. (90% sure of preciseness of quote). After this there was a click alike to that of a tape recorder been switched off. Then there was a return back to the church leader and of what he was speaking.

* It was of the sermon sections presented on radio over the 2012 Easter weekend
Cardinal Pell “Our Hearts”. Cardinal Pell was head of the Melbourne Diocese in the late 80’s/90’s.

26th April 2012: Koori Radio approximately 5.47pm

A very good modern type of war cry rap song by Australian aborigine group.
Of the song - “Newcastle Sun” – “upstairs there’s a headless skeleton”.

In of near 27th April 2012: ABC Radio

A report of a young female’s body been found at Bethlehem Falls. She was abducted earlier in the week from Mullumbimby. (I was a school boy at Mullumbimby High in Years 10; 11 and 12. Myself and my family resided at Mullumbimby from 1978 to early 2000’s.)

On Wednesday 2nd May 2012 on either Channel Seven or Channel Ten there was a ad promoting Nature B and the Heart Foundation. In the ad it showed a young female of her early twenties in playing worship like action with a waterfall in the background. This ad to my knowledge was only run for a very short time.

* Nature B promoted itself very heavily on 2GB in 2011/12. Nature B’s telephone number has 147 in it. (Me 47 in 2011/12).

* I remind: There is a very intense U.S. propaganda agenda pursuing to have me recognised as Mr B.

28th April 2012: ABC News Radio

Interview with Bulldogs coach Des Hasler after Bulldogs loss to Manly. Hasler started the interview with and in no context “He’ll always be Mr B”.

PART 15: RACING INDUSTRIES EXPLOITATION OV EVELYN GREENUP'S DEATH

* It is needed to be understood that Sky Racing has been exploiting me in its content for at least the last nine years. It is to be reminded that Sky Racing is owned by the Murdoch's and affiliated with B Sky B.

I am extremely certain there is a collaborated grouping of persons within Victorian and NSW racing that have intrinsic knowledge regarding the death of Evelyn Greenup. The collaboration nexics in actions of exploitation with the Victorian Labor party; the Melbourne Catholic diocese; TAB; CentreBet; Sky Racing; TVN and 2GB.

Examples of exploitation:

In 2010/11 Sky Racing – there was a regular racing promo that showed Victorian Premier John Brumby cutting the ribbon to open a new racing venue of type. Brumby while cutting the ribbon looks at what would be correct to assume were invited dignitaries. Brumby lip speaks – “1; 2; 3; 4 Greenup”.

12th October 2011 – Sky Racing – voiceover commentator talking of “**a lucky punter**” winning a “**four and a half times**” parlay bet. In context of the final leg of the wager been successful- voiceover commentator “**had to wait a little while but it was worth the wait**”.

I do not know the details of the other legs of the wager but the final leg was a \$1.70 favourite winning Race 5 in Melbourne. The horse's name was Atlantic Jewel and the jockey was Michael Rodd. The horse's trainer is M.A.Kavanagh who I am certain is a Melbourne trainer and a catholic. The voiceover commentator spoke that the punter won near of a quarter of a million dollars. I am not exact on the how of a parlay. I believe it can be conducted over a number of days and combined in different sports. The need is to learn the exact sums and the bet determinations of all legs. I reach by hazarding that one of the bets involved the Melbourne Heart A League club. I reach hazarding that the date of the outlay was October 4. I hazard that the exact winning sum was either \$247,500 (My age 47 in 2011) with a outlay of \$55,000. (Muriel Craig age 55yrs) or \$207,000 (year 2007 been the re-emergence of Evelyn's murder in television and newsprint) with a outlay of \$46,000 (my age and/or Harts age in 2011).

* At the end of this coverage section Sky Racing went to next race which was Race Five in Sydney. That race was won by a horse named Triple 6.

After nearly two decades of wagering standard bets on horse racing through the monopoly of TAB; my learning is very certain that there are routinely interstate interconnection preset winners in thoroughbred racing; thus meaning- a race five winner in Melbourne is preset with a preset winner in the next race in Sydney-. While Triple Six won only by a short head it was a final two hundred metre two horse race and it was never headed. It was no coincidence.

There did however seem genuine want by horse and jockey of the second horse to win. (a disgust like want to beat the preset agenda). In my learning of the interstate winner presetting this is very rare.

The Atlantic Jewel race was sponsored by Schweppes. (It was ov this time that for many months the unisioned media conservative propaganda ov “shhhhhhh” was been used in many news stories. Shhhhhhhh is/was part ov Schweppes billboard promotions.)

Atlantic Jewel's jockey was Michael Rodd.

TVN program their coverage with a winning jokey interview in the mounting yard. The jockeys for a long time have had pants leg sponsorship promoting **JAYCO**. In this interview it was blatantly obvious Rodd deliberately positioned himself to show his right thigh/hip. Rodd was very deliberate in his actions and deliberately adjusted his pants so to show the letters **JAY** only. This very much appeared pre planned with the TVN cameraman/producer. (The emphasis or mandatory to show the sponsor in interviews prior to this and since has not been.)

After the interview TVN switched into a interview with Doug Harrison. Harrison was wearing a peak cap with the letters BCS insigned. It would be reasonable to think that BCS must be the insigne ov the stable that Harrison works for.

- The four boys said they took Evelyn back home.
- Police received two sightings reports after this, one at about midday at the waterhole the second at 4pm in James Park where the kids often play on a old tractor.
- Detective Sergeant Lance Chaffey of Newcastle who is leading the investigation- doesn't attach a lot of importance to the sightings- “We believe she was taken back to the Reserve but we don't know much else.”- “It's like we've come up against a brick wall the little girl has vanished that's all we know.”
- Rebecca wasn't sure ov the clothing Evelyn was wearing. She last saw Evelyn asleep the night before she disappeared.

- Bowraville self recognises itself as having serious racial problems. Clashes between black and whites are common with the word “coon” used by many whites and “white trash” by aborigines.
- Approximately 250 aborigines live in Bowraville.
- Until late sixties town was segregated alike to that ov the Deep South in America.
- Charles Perkins stopped at Bowraville in his –freedom bus ride-.

Larry Kelly (photo) ov the Bowraville Aboriginal Land Council recalled.

- Thirty years ago the school was segregated. School was Catholic. St Patrick's sports meeting were the only time they were aloud to mix.
- At the movies there was a black and white section.
- In result ov Evelyn's disappearance the town community black and white began talking to each other 'Everyone pitched in and I think they got a little bit closer said Lance Chaffey.
- Land Council office just opened (where the interview was conducted.)

Bruce Greeves agreed – “What happened to the little girl brought us together. The ice was broken. We started talking.” ‘No one cares if the little girl is black or white. She's a little girl. She's four.”

Larry Kelly – “In context ov Evelyn's disappearance- “We support one another; we came together white and black.” ‘It could be the start ov something good. We've all got to live here so we've got to accept one another, no matter who we are.”

In Macksville however not so:

- A group ov whites drinking in the Star Hotel – “I don't know what the fuss is all about she's only a coon” said one ov the patrons; all ov his mates agreed in hoots ov laughter.

Nambucca Shire President Max Graham – He couldn't see much change. “The big problem is the young aboriginal fellows drinking all the time, calling the girls names; abusing people. It's got to stop. It's gone far enough. The police can't do anything with them. The young fellows just laugh at them. I hope something can come out ov this but I'm not sure it will.”

Larry Kelly- acknowledged drinking's a big problem amongst the aboriginals. “Yes along with unemployment alcohol abuse is one ov the biggest concerns.” “Ov course the whites never mention the abuse amongst their own people. They always point the finger at blacks.” “And who supplies the alcohol? There's two pubs and two clubs in this town and there not run by blacks. But times are changing. I can see some hope in the future. Maybe little Evelyn's disappearance tragic as it is will help us all.”

In this a snowball effect would capture a further fifty to sixty persons who have/are withholding critical information and grossly exploiting the sacrifice ov Evelyn Greenup for profit and gross abuse ov positions (the public domain ov mass media; public office and the industry ov horse racing).

I believe in absolute certainty that the following persons are the direct main actors in the actual acts ov abduction and sacrifice:

- 1- Jay Thomas Hart
- 2- P.J. Greenup
- 3- Muriel Craig

In completion ov my research I'm in total certainty that Evelyn Greenup; Colleen Walker and Clinton-Speedy-Duroux were sacrificial deaths conducted inside a global – nationalist ideological interpretation ov 666 satanicism.

The three 6's are:

- The Catholic Church chaired inside the Melbourne diocese during the nineties.
- The Bowraville Aboriginal Land Council with a connection that stems down into Newcastle and up into Townsville with a certain surety that Nathan Tinkler is one ov the prominent new King figures.
