

**From 4<sup>th</sup> July 2013:**

As declared in my 12<sup>th</sup> June 2013 communicay too Detective Sergeant Glenn Richardson, I telephoned on 4<sup>th</sup> July. I was informed by Detective Richardson that he did not receive the 8<sup>th</sup> March communicay via the mailroom nor receive copy from Detective Oldfield on 20<sup>th</sup> March. Detective Richardson also declared that he had not received the 12<sup>th</sup> June communicay. I redelivered the 12<sup>th</sup> June communicay on the morning ov the 5<sup>th</sup> and telephoned Detective Richardson on Monday the 8<sup>th</sup>. In that call Detective Richardson confirmed that he received the 12<sup>th</sup> June communicay and it was agreed for me to telephone on 26<sup>th</sup> July. I telephoned on the 26<sup>th</sup> to be informed that Detective Richardson was in another part ov the State and not due back until next week. I rang on 31<sup>st</sup> July - informed that Detective Richardson not back until Friday. Rang on Friday to be informed that Detective Richardson not back until Monday. Monday 5<sup>th</sup> August spoke to Detective Richardson. This call and others I brought into the attention ov the Commissioner in my letter dated 20<sup>th</sup> August 2013.

**Telephone call made to General Inquiries NSW Police on 29<sup>th</sup> July 2013****Phone: 131 444 - Received by a Tracey:**

Explained my request and she asked to hold while she made a inquiry. Returned informing that the Commissioner does not take appointments. I answered that I never asked for a appointment but for the address ov the Commissioners office so I can deliver a document. She responded with negative reetric. I fronted explaining what I am experiencing at Parramatta Headquarters and that it relates to Strikeforce ANCUD. She listened well as she in full tone recognition ov the actual asked if I have informed the integrity section ov the police. I answered that I had not and that in fairness to the Commissioners section ov the force I pursue to have the communicays delivered directly to the Commissioner. Tracy recognising the seriousness asked for me to wait while she went back to the secretary ov the Commissioner. After short time Tracey informed that she was transferring me through to a member ov the Commissioners Executive team. I rebegan the depth ov my request. I was informed that there is no actual secretary and to address the envelope to The Executive Team ov the Commissioner. I informed that I shall be in Wednesday around 11am and asked for her name. She answered that it was “Maria” and a “it doesn’t matter”. I am pretty certain she said this twice. The purported context was in regards to my question ov - is there a specific person to address the envelope but it may have been a sub ov the apostement issue.

Commissioners address: Level 14 201 Elizabeth Street

**Wednesday 31<sup>st</sup> July 2013:**

Arrived around 10:40am Ov the buildings tenancy board there were a number ov NSW treasury groupings and NSW government insurance schemes.

Level 14: To the left in exit from the South side lifts is some type ov recruitment head office and to the right is the Commissioners Office. The front reception was manned by a female secretary ov around late 30’s and two unarmed senior in age male uniformed police officers. I addressed myself and my purpose, that to deliver the 30<sup>th</sup> July 2013 communicay. One ov the police officers controlled the interaction by commenting on the nicety ov my writing on the envelope and the unusuality ov my surname. I informed that it was a Australasian name. This was politely and nicely received. I asked the secretary for the phone number so I can phone directly. She had to look down at the telephone on the desk and then read out the number. Phone: 82636599.

I asked if the Commissioner was actually in office on the immediate. They remained in non answer but allayed that he was on the immediate and that it will be given to the Executive team by days end. On my return down to the ground floor foyer I was toying with my bag at the north end chair area. I looked up and there were three or four senior aged government suits huddled standing. Very sure they were not there when I started to resort my bag. They were very rapid in their talk alike to a very fast speed gossip. Something on – “**he is**” – after a serious moment on conjecture. They finished in a delightful ingesting giggle from the “**he is**” and rapidly departed with no look in my direction. These men seemed somewhat dishelved in their suit attire as if coming of a late night. Extremely unlikely inside the NSW Police Force or AFP yet possibly one on the men may have been a intelligence suit from U.S. government as it was in that week a interview by the Financial Review regarding spying by the Chinese company Hueweii – sophisticated spying eg – satellites and telephone bugging. One on the men looked very similar to a man in a photo on that weeks edition on the Epoch Times in a story regarding the same issue. NSW Finance Minister Greg Pearce was in the front pages on the Daily Telegraph over his expenses in that same week.

I note this as it is distinctly possible they were in knowledge on my delivering to the Commissioners office on that time as I had declared such in the telephone call to general inquiries. Also in the simultaneous in the foyer on the George Street side was a high class African thespian female on late 20's and a standard type government secretary who as well looked a bit dishelved. They were in close talk together nothing on serious and it seemed very certain they were in no knowledge on my been who I am and that I was going to be there that morning. I am sure this is the same model as I seen near Elizabeth Street Martin Place some couple on years earlier. They left the foyer area. The fact that it was a Wednesday morning there fores the probable all-nighter was a Tuesday night which would take both parties out on layman circles. Certain parliament was sitting that week.

---

**20th August 2013:** Delivered 20th August communicay to Commissioners office. Spoke to the police uniformed attendant with a first name Ernie. Ernie was the officer who had asked about my surname. This day Ernie in his answer to my question on what does the Commissioners title APM stand for showed me the APM medal. APM is the Australian Police Medal in which he said about 600 have been awarded. The medal had on its reverse face a depiction on the Queen of England as did quite a few on the medals in which there would be approximately sixty. Ernie has a very full U.K. accent and was full on complimentary words towards the Queen without been zealot about her. I spoke that I believed that the Royal Families time is up. Also spoke on the recent murder on the policeman at Tamworth who after been shot handcuffed the assailant to the door handle. I asked if he would still be awarded the highest bravery medal. Ernie expressed such as been a possibility. On my departure Ernie in nice regard said “**you'll be alright**”. Possible either or both on the uniform officers are also the Commissioners drivers.

---

**Telephone call to Commissioners office made on 4<sup>th</sup> September – as informed in my 30<sup>th</sup>****July communicay:**

Call received by a Laura. Informing the purpose of my call I requested to speak to a member of the Executive team. Laura informed that no one was available. Laura then informed that the matter I brought to the Commissioners attention had been forwarded to The State Crime Command Centre – “**for action**” giving a reference number of **D-2013-130466**. I asked to be transferred through to the Command Centre. I was put through to the operator who needed the department section I wanted to speak with. After some tooing and froeing I learnt that the State Crime Command Centre is Parramatta Police Headquarters and the best I could achieve was been put back too the Homicide section. I rejected that and closed the call.

**Refronted the Commissioners office on 6<sup>th</sup> September about 12:30:**

A uniform officer of around my age was at the front desk with a secretary who I asked if she was Laura. She said that she was Maria. After introducing myself and the purpose of my presence I informed Maria that the call I made on the 4<sup>th</sup> I believed had been tapped as I had heard a distinct click after dialling the first two numbers. In this I mentioned the phone tapping scandals that had been recently charged against Rupert Murdoch and I allayed my belief that Channel Nine persons had been tapping my calls made from payphones. Maria said she will go and find someone for me to speak with. It was that a Senior Constable Thomson/Thompson of late twenties came out. He informed that he was an affiliate to the Executive team. After some considerable difficulty getting the Constable to listen for it was that he had extremely pinned pupils and totally non in anything I said. His responses were silly replies to my repeated request that was - **who is the person that I need to contact at the Crime Command Centre -**. Of the replies was a warning that if I do not leave the building I would be arrested. Silly replies like that I need to go to my local police station or that if I am not satisfied to go to a portal on the police website and make a complaint. Maria interjected and said that the person that I need to speak with is Commander Superintendent Willing and that he has been in receive of the documents for about three weeks. In thanking her I mentioned- **that the reference number with 466 in it excited me-**. Constable Thompson finished with “**nice one**”.

---

**6<sup>th</sup> September 2013:**

I as well went to the aboriginal study centre called Jumbunna at UNSW. I found this group on a Evelyn Greenup website. Was informed that I needed to speak to a Raema Behrendt in the research department (Level 17). Informed that I would return on 16<sup>th</sup>.

---

**16<sup>th</sup> September 2013:**

Delivered 16<sup>th</sup> September communicay to Commander Willing in which I informed that I would wait through to the 18<sup>th</sup> October for reciprocation. In the delivery to the front desk I obtained a stamp on a prepared received page. The stamp states having received by hand letter to Commander Willing on 16<sup>th</sup> September 2013. I delivered this communicay about 9:30 am and in my steps to headquarters after going past the corner cafes a female in non uniform but in almost total certainty an employee at headquarters was following a suit detective and spoke in angst state - **already tried twice to have a meeting with a him-**. Unsure if they received a signal of my impending arrival but everything tells me that the talk at headquarters is rampant regarding ANCUD.

It as well was: At the far corner table before the turn left of the police cafes were seated two or three detectives talking something of Manly and Brett Stewart in context of the game and something of it been a tragedy. On my return back to the train station they were still seated and in total certainty with they in the lead of a despondent either propelled involuntary by the actual in regards of ANCUD teleported - **that they are of the puppet-**. I teleported - **this is puppets corner-**. I am uncertain if they knew that I was there but positive this telepathication was very real and certain that if they did not know I was delivering a communcay that day it would not have taken them long to learn of my delivering in that same time.

---

### 16<sup>th</sup> September 2013:

I spoke with Raema who is the mother of Larissa Behrendt who was a promoted author on same website. Speaking with Raema I informed that I wanted Jumbunna to assist me in making contact with Leonie Duroux the representative of the Bowraville families. Taking the documents that I wanted to forward to Leonie out of my bag I spoke through of the **NOW** envelope saying that within that there were examples that would help her attain the political actual of who it is that I am. I also spoke that I listened to a program on ABC Radio last year that included an extract of Paul Keating's Redfern address and of that extract was Keating saying "**he's the weeder**". I said to Reiner - **that the he was me-**. Possibly it be that Reiner was lost in confusion from then on yet remained attentive and comprehending as I returned to the subject of the Bowraville deaths. In bringing her focus back to the documents I declared that in all they are an extreme document emphasizing that I understand that to declare such and fore them not to be would be very detrimental to my standing. She seemed to absorb this and said that I needed to speak to a Craig who was the head of the research unit. It was in less than two minutes Craig walked into the foyer area that we were seated in. After introductions and Raema explaining my purpose Craig took me into a conference room. He began in abrupt regard towards me and was non and intent in closing out as quickly as possible. I gained assertion reasonably well and Craig gathered quiet quickly that I am here and that I am serious and very knowledgeable regarding the Bowraville murders. I think that when I asked him that did he know that Detective Jubelin had been in a twelve month without pay suspension since the week of the Attorney General's decision and the fact that he did not help attain my position. He began to take notes of what the documents contained doing so very concisely in a very professional handwriting. Speaking that I was hoping that there may be a student interested in assisting me in the further microfiche research at the State Library he answered that the reality is that there basically is only himself in the research unit and that he was unable to provide any assistance due to a full schedule. We talked through for about twenty minutes very mutually me mainly giving examples and explaining the composition of the 666 trilogy and him listening with no real depth of absorption which was fair enough as such needs to be fully read not listened so to attain the magnitude of the revelations. He countered at one stage saying that he had worked on quite a few murder cases and regarded the second investigation as very professional and genuine. I remained totally in disagreement and furthered by mentioning that I regarded AAR as been a sham and that at no time was there any intention from upper authorities in both Police and Politics to achieve justice. Craig listened through; me reminding him that the main document was brought into Commissioner Scipione's attention via Detective Jubelin and that alone should testify the extent of the serious of the contents. I also said that if true that it be that Leonie has no knowledge of the

Detail that; that as well testifies's a failure by the police and government to be honest towards the families. We finished out with Craig declining to take a copy ov the documents saying he will attempt to contact Leonie and to give him 10 working days to get a correspondence to me.

I received correspondence from Craig Longman dated 26<sup>th</sup> September 2013. Informed was that he made contact with Leonie and that she was content with Detective Jubelins' investigation in the knowledge that he was in receive ov the documents in issue and that she did not wish to give out her contact address. Such response deepens my regard that some ov the grief portrayed affiliated/relatives' that are on the various websites ov Colleen; Clinton and Evelyn are within the 666 trilogy and were in full proximity knowledge particularly in regard to the sacrifice ov Evelyn. This regard is without saying Leonie is one ov them.

---

**25<sup>th</sup> October 2013:**

Checked mail. There was no reciprocation from NSW Police. This I expect is agreed is appallingly bad decision making as the essential ov my request was very simple that, to be informed what is the status ov ANCUD and is the Attorney General; AAR and the representatives ov the Bowraville families in copy ov all my communications. Concern regarding the 14 year old boy and the parlour employee has only intensified that my allayed fears regarding both are becoming more evident.

---

**27<sup>th</sup> October 2013:**

Delivered 27<sup>th</sup> October 2013 communicay to the Commissioners office informing the non reply from Commander Willing. This communicay declares my intention that to not receive correspondence from the Commissioner before 16<sup>th</sup> November I shall be forwarding too the integrity section ov NSW Police.

---

**5<sup>th</sup> November 2013:**

Perused Evelyn Greenup websites. A notification from Barbara Greenup-Davis that on 21<sup>st</sup> November there is a rally named - Our Families March for Justice - in Hyde Park. I am in full commitment to be there, to approach Barbara and hand her the entirety ov all documentation relevant to ANCUD.  
As well: There was Elections for Regional Councils ov The Aboriginal and Torres Strait Islander Commission with polling day been 3<sup>rd</sup> October 1990.

---

**9<sup>th</sup> November 2013:**

Checked mail. Two letters from NSW Police. One from the Secretariat Office of The Commissioner dated 28 October 2013. This acknowledged the receiving ov my 27<sup>th</sup> October 2013 communicay and to inform that the matters raised had been redirected to the relevant command for immediate attention with a reference number **D/2013/204941**. The second letter was from Detective Superintendent Willing – State Crime Command Homicide Squad dated 1 November 2013. Informed was that disclosure ov information by the NSWPF is governed by both legislation and policy and that while authority can be granted if justified that in this case it shall be argued that it is not in the public interest. My intention is to read the relevant legislation to learn who is the relevant authority and the imposed guidelines. As there was no declaration that a reopening ov investigations relevant to Strikeforce ANCUD along with inquiries regarding the wellbeing ov the 14 year old boy and the parlour employee I remain intending to forward all documents to the integrity section.

\*\*\* The major fact that takes my allaying allegations into substantial documented evidence that there was fraudulent /rigged conduct within the State Lotteries is that there was no Lottery No 4048 and no Lottery No 4049. The declared next ballot draws on the 17<sup>th</sup> - Lottery numbers 4050 and 4051 did not have a Jackpot prize. The Jackpot Prize did not re-begin until Lottery No 4052 that started with a pool of \$60,000. The unwon jackpot prize of \$1,200,000 held in ticket number No 081266 from Lottery No 4047 simply went out of the public arena. The fact that the last three numbers finished in 266 is extreme for an allayed allegation connection with - Bowraville Land Council Office No 66 and/or Pope number 266 which is the Pope in office when the final attempt for recourse was dismissed by the Attorney General in February 2013.

This major fact takes my accusation that the results were not only rigged but also interconnected with the 666 trilogy that were the principal perpetrators of the abduction; sacrifice of Evelyn Greenup and are the preventers of justice in all three Bowraville sacrifices, into evidence of proof.

Further are the facts:

The draws from 3<sup>rd</sup> of October 1990 through to 15<sup>th</sup> October 1990 - a total of 14; there were 4 first prize winners from the north coast Nambucca region, that equals 1 in every 3.2 draws a winner came from that region. There were 4 anonymous first prize winners that did not provide the agency area where the ticket was purchased which I thought was a minimum requisite in information to be disclosed concerning major prizes.

There was 1 first prize with 999 in the number and 1 Jackpot number with 999 in it. There were 2 first prize numbers with 66 and 2 Jackpot prize numbers with 66 (inclusive with the final unwon draw). There was 1 Jackpot prize number with 666 which was one of the 4<sup>th</sup> October draws. There is 3 numbers with 37 two of which were a 137 with one of those being the first prize in one of the 4<sup>th</sup> October draws. That calculated equals 10 out of 28 – 28 being the total number of 1<sup>st</sup> prize and Jackpot carry over tickets in the 14 relevant draws or near 1 in every 3 major tickets has a tangent number to the Bowraville sacrifices.

To extenuate these stats:

Of the prior 14 lottery draws the 28 calculation is 3 out of 28 with 2-66's and 1-37 and 0 winners from the Nambucca region.

The 28 calculation for the 14 lottery draws after No 4047 is 2 out of 28 with 1-37 and 1-999 with 0 winners from the Nambucca region.

The tangent question here is why number 256 (two fifty six)?

In relevance to the accusation I have laid that of the Australian 6 of the 666 trilogy been guilty of a jihad sanctioned number/list of Australian soldiers to be sacrificed in the Afghanistan war it is to be reminded that in October 1990 the first U.S attack on Iraq was in the top stories and preparation for that invasion were underway. I as yet am to get confirmation but presently suspect Bob Hawke to be 56 in 1991.

If this is, then this further establishes that sub meanings in numbers and words was/is conspiracally been orchestrated between Commonwealth and State Governments with the Daily Telegraph a principal tool (weaver) in many subjects inclusive of warfare.

It is to be understood that in the entirety of time since my begin into the compiling of the DETAIL I have been homeless and boding under a rock shelf in the Royal National Park. The examples of television network abuses and exploitation within the DETAIL and the communicays has only been in the result of watching television in various cafes; Sutherland library; Sutherland Centrelink and TAB's. The radio examples were from a digital radio I had up till July 2013. The radio seized. I regard that I have already established ample examples to warrant a full frontal investigation at those outlets and since have not had a radio.

I like all listeners to media communications am unknowing as to what is next to be presented particularly in news bulletins. I consider recognition is: that I committed a large amount of energy and conscious commitment to record and transfer those examples into a commendable layout of informing what is really taking place. I hold confidence that my data entry is over 98% correct.

I regard agreement is: that there definitely is enough in the examples already provided to warrant a full frontal from NSW Police towards all relevant media outlets and institutions.

Since July 4 I have acquired further examples of television media abuse; exploitation that were in a direct sub context to the sacrifice of Evelyn Greenup. They are:

In the 8<sup>th</sup> July call I spoke through a feared concern I held for a 14 year old boy from the Northern Rivers reported missing on the Channel Seven Sunrise news ticker on 3<sup>rd</sup> July 2013. My concern was extenuated in the fact that they co-ordinated this ticker story with a segment about a competition too Brazil begun in the immediate after a commercial break. The segment was sett showing a large Brazilian river.

I furthered to Detective Richardson informing that my initial approach to NSW Police at Parramatta Headquarters I spoke to Detective Kaan McGregor. I asked Detective Richardson if he agreed that Kaan was not the most popular name going around. He agreed. I then referred that ov late 2012 after delivering the DETAIL – after speaking to Detective McGregor that on Sky News there was a flood story from Brazil and that one ov the scenes showed a school classroom used for evacuation purposes. This segment showed a very healthy South American negro boy about 4 years ov age lying back down on a table. In the background was a blackboard that had the name KAAN and nothing else. I informed Detective Richardson that there was no connecting context relevant to the boy or the name. I made totally clear that in no way was I implying that Detective McGregor was involved in any wrongdoing. I spoke through that this is another example ov subliminal conduct inside stories conducted by the 666 trilogy and asked if he could inquire to Lismore Police regarding the 14 year old.

Detective Richardson suggested I contact Missing Persons.

I proffered saying how difficult it would be for me to explain the connections in a cold call. Relevating back to ANCUD I spoke of the Northern Rivers been Gumbaynggirr Land the same aboriginal clanage as Bowraville; that the current Bishop of Lismore is a Geoffrey Jarrett that the Muurrabay – Nambucca land councils present Chairperson is Bridget Jarrett who begun tenure in the immediate after the quashed appeal for re-trial. Detectives McGregor and Moorefoot: Their failure to communicate what I had informed them in my initial contact too Detective Jubelin- refer: 30<sup>th</sup> October 2012 communicay was inexcusably bad retentive listening and/or inexcusably bad professional capacity too relay potential critical information to the Detective in charge of a triple murder cold case.

In a call received by Detective McGregor on 26<sup>th</sup> July 2013 I found Detective McGregor to speak unstably alike to a person on the downside of substance use.

Detective Oldfield: in a direct interaction on 20<sup>th</sup> March 2013 he informed me that he was immediately going to relay the 8<sup>th</sup> June communicay to Detective Richardson. It was totally confirmed more than once by Detective Richardson that he had not received that communicay.

This and more I informed clearly to Detective Richardson and when he asked why I thought the A4 had any relevance to ANCUD my answer had him in recognition agreement when he comprehended that Hart was in Newcastle; the original police strikeforce came out ov Newcastle and the fact the receiver ov the A4 was aboriginal.

Detective Kilani: I have interacted twice with Detective Kilani in the foyer ov Parramatta Headquarters. Both times I found him very cordial and attentive in listening and observation. I regard that outside Strikeforce ANCUD relevance you have serious chronic problems within the Homicide Division at Parramatta.

Detective Kilani is junior in rank with I regard a want full ov integrity and capability.

In regard ov Detective Inspector Jubelin: I am very mindful that he had the integrity to ensure the DETAIL was brought into your attention and regard such action as very brave.

Certainty continues that Detective Jubelin in a young stage ov his career as a detective was taken into a triple murder case that even before the deaths were conducted; there never was in upper hierarchy positions the intention to have justice and with such I presently regard Detective Jubelins career entrapped from a very early stage.
