

Notes -Script and Comments from telephone calls made too Detective Sergeant Glenn Richardson Homicide - Police Headquarters Parramatta.

First call made on 4th July 2013 as I informed in my 12th June communicay to Glenn that I would be doing such. Call made at approximately 11:10am from the payphone outside the surf and ski shop Station Street Engadine.

Transferred through to Glenn – introduced myself; asked if I could call him Glenn. He answered in a sentiment want for such. He informed that he did not receive the 12th June correspondence and reconfirmed that he did not receive the 8th March correspondence ov the 8th or from Detective Oldfield on the 20th March.

He became abrasive in my informing that the purpose ov my call was regarding Strikeforce **ANCUD with rectric such as – what do you want – don't tell me it's to do with Strikeforce ANCUD**; just tell me briefly. I answered that the entirety ov my call was to do with Strikeforce ANCUD and how do you want me to be brief when I 'm in purpose ov a letter that is 27 pages in length. He started to retract from his abrasion as my rectric was very front foot and I suspect Glenn was rapidly comprehending that I was not to be dismissed easily. Glenn declared that he never has been on Strikeforce ANCUD and declared that he has not read the DETAIL. He informed that Strikeforce ANCUD is presently suspended as from the 9th February. Glenn confirmed that the Police Commissioner was still Scipione. He assured this with a distinct humble (Christian like) regard and admiration towards Scipione. He declared after my question ov - if he was concerned at the fact his mail was been intercepted with either – “yes I am concerned” or “yes I am very concerned”. Lost his way in result ov my manner by stating that – ‘Craig if your going to talk to me like I am idiot we won't continue’.

Glenn confirmed he recalled talking to me in foyer with Detective Jubelin on 28th November – ov which I reminded him that Gary declared that the DETAIL was on the Commissioners desk. He non replied to this.

I begun close out to the call by me acknowledging that ANCUD is suspended and that he never has been on ANCUD but for him to understand my necessity to close communications by re-delivering the 12th June communicay informing I would do such tomorrow(the 5th). I asked if he wanted me to inform the front desk ov my arrival and therefore he come down and collect personally. He answered **“that won't be necessary”**. I informed that I shall telephone on Monday 8th July so to get a confirmation from him that he received the communicay. He understood such.

Notes ov else: He corrected my pronunciation ov Jubelin there thus allaying that he holds strong respect towards Gary. Overall he sounded somewhat disheartened most likely his head stuck in learning that Detective Oldfield was intercepting his mail, yet this seemed in him before informing ov such.

Delivered 12th June communicay approximately 8:10 am on 5th July.

Ov my approach at the left hand turn with the corner coffee shops that are obviously frequented by personal from Headquarters there was a male voice in the seated persons **“turn left”**. This said in the very immediate ov turning left. At the nearer coffee shop to Headquarters at the seated tables near the handrail was a table ov two male suit officers. One spoke something ov **“Ray what's going on”** in a overloud level ov voice. That was all I heard. Perceptually obvious that he was talking to the suit opposite him at the same table and that he was not Ray. It was in a context ov him very recently fronting a Ray asking him in

suspicion regard as what the ***** is going on. I suspect the Ray may well be Ray Hadlee mindful that Hadlee's son apparently is a police officer and that my communicays are very leaked within having very real accusations laid against Hadlee and 2GB. At one of the next tables was a person- did not fully see seated with a very senior (mid late forties) uniformed female police officer- very attractive with dark healthy alluring eyes. Her uniform seemed very high in command and she and myself made complete total eye contact in a manner that she was there knowing I was going to turn up and there thus wanting to observe me. If such be, then the call to Glenn and my informing of my intention to deliver reached in a near immediate police suits and uniform hierarchical with the - turn left- suit in a co-ordinate knowledge with the female uniform. She may well be more close to the other police headquarters and Commissioner Scipione.

Notes from telephone call made on 8th July.

Call made at just after 11am from the further of the two pay phones outside 25 East Parade Sutherland.

Transferred through by a Detective Grant Davidson.

Asked Glenn if he received the 12th June communicay on the 5th. He answered that he just received it at his desk only two or three minutes ago describing the fact it was in a white A4 envelope with my contact details on the back. I asked if he has any comments in which he did not commit in any way or direction other than to say that he would correspond as he informed he would in our prior telephone call. I went into my comments regarding his missing mail asking if he had obtained copy of the 8th March communicay. He answered dumbly-ignorant considering I informed him on Friday that he should be in receive of a 8th March commmunicay. His ultimate answer was that he had not. I then asked if was going to forward the communicay to P.C Scipione. He did not commit. I front footed by stating how ludicrous it would be if he didn't as the correspondence stems from the DETAIL which is on the desk of the P.C. He did not commit started to go into that he has a desk full of work.

I asked Glenn if he wanted me to inform some information regarding his missing mail. He answered yes. I informed that I delivered the 12th June communicay at around 4pm on the 12th and that it would be that no warning that I was going to do such would have been possible. I informed that I personally handed the document to the mail room attendant who was a large unkept dressed pacifican of diabetic nature – not fit and proper for Police Headquarters. Glenn's type of murmur seemed in a agreement and like at this.

I informed Glenn in regard of the 8th March communicay that on the 20th March with Detective Senior Constable Oldfield was Detective Sergeant Constable Tamer Kilani. I made my opinion of how I regarded Kilani as a good officer very attentive – straight and good. Glenn in his type of murmur was immediately in agreement too this. I knew that I now was in his complete attention. I told him how Detective Oldfield took copy of the 8th March communicay and immediately photocopied X3 such, with assurance that in the immediate he was going to give you a copy.

I informed Glenn regarding the 8th March communicay that on 18th February I spoke with Detective Sergeant Constable Julia Bradley and Detective Sergeant Constable Tamer Kilani in who I informed I would deliver a letter on the 10th addressed to yourself. In the unknowing at that instance that the 10th was on a weekend – there thus the 8th March communicay was the intending 10th – delivered on the 8th. I then begun talking of the persons seated opposite me in the foyer on the 18th describing the large soft healthy man seated with some type of blood cyst between his eyebrows and that he was talking to a female of aboriginal descent about 30 years of age in suit like attire. Informed that he handed her a A4 envelope layed thick in about 20-30 pages in total and that I heard him say “oh it's Newcastle”. I described

how the female was very pleased-excited and full of thanks in receiving the envelope and that she seemed of good standing in her objective too the information received yet perhaps naïve in whom she was in the intention of sharing the information with. Glenn remained non-committal in this, however with a question of - how are you sure that the envelopes contents were related to ANCUD. I reminded him that Hart was in Newcastle and the receiver was of aboriginal descent. This swayed Glenn in his sentiment that I am most likely correct. I am also pretty certain I reminded him that the original investigation begun in Newcastle. I informed that the large man definitely was of Headquarters as he went upstairs after talking to the female; said perhaps he works in records or of such. Glenn refrained from making any comment.

I then talked through about the missing 14 year old boy reported on the Channel Seven ticker on the morning of the 2nd July. That the 14 year old was missing from the Northern Rivers and that is Gumbayyirr land and that they are the clan of Bowraville. Informed him that the Catholic Church diocese of Lismore oversees Bowraville and that I have real certainty of extreme wrongdoing at Channel Seven and within the Catholic Church closing that the head of the Catholic Diocese in Lismore is a Jarrett and that in the very recent there has been a newly elected head of the Nambucca Murrumbidgee Land Council a Bridgette Jarrett. I asked if he would make an inquiry to Lismore to learn about the status of the missing 14 year old. Glenn suggested that I telephone missing persons. I expressed how difficult it would be for me to communicate the direction of my inquiry. I then went into telling him about the scene from Sky News from 2012 where the story was of a dark Negro boy child on a table in an evacuation room in a school in result of the floods in Brazil. Told how there was no real context in the story and that scene and that at the back of the room was a blackboard that had the name KAAN in chalked letters. I then went into how of my initial inquiry at Headquarters I met with Detective Kann McGregor and that surely he would agree Kann is not the most common name going around reasserting how very obvious the leaking of information with all things regarding myself and ANCUD. I myself went into sentiment pleading for him to inquire about the 14 year old as I am sure I mentioned that it was obvious that the Negro boy was laid out as if awaiting to be sacrificed.

Glenn informed that he had a table full of work that he **“was under the pump”**.

I went into asserting that my memory is very good and how at the 28th November convene that he answered for Gary when I asked him if he had any personal relationships with anyone at the ABC. And that he-you answered **“No”**. I established that I was from that convene in belief that he was on ANCUD.

Realising that the communication was ending I returned informing that I understand that I must redirect my further inquiries to the Police Commissioner but need to close out my inquiries with him and suggested that I ring two Mondays from today. He answered – **“mate how about three Fridays from today”**. I agreed and suggested around 11 am in which he agreed.

Notes: Of the initial transfer from Detective Davison heard **“we’ll record”** and a very brief telephone wait music then into Glenn speaking.

Glenn in his initial opening said that he would correspond to me like he said he would. I asked if incoming calls to Headquarters are mandatorily recorded. He answered that they were not. I mentioned how lack that seemed.

Notes: from telephone call made on 26th July 2013 from same phone as the call on the 4th July. Call made at approximately 11:05 am.

(It was in the dialling of the numbers that after I entered the 88 there was a very distinct intercept click noise from the phone.)

Received by: Detective McGregor. He informed that Glenn was not in, that he was in another part of the state and that he won't be back until next week. I asked if he knew what day. Answered with I don't know I 'am not on his team. I said in return query that – he's on a team? – What's the name of the team? McGregor said something alike to –your Ted or team Ted rapidly annoyed at his answering by then asking who are you? I answered with my name in which McGregor in abrasion said something alike to –no who do you belong to? I answered that I am a citizen and that the purpose of my call was in regard to Strikeforce ANCUD. Unsure but this may have been when he said the comment of Ted. I mentioned in ask if did he say something Ted. McGregor still abrasive did not comment except in undistinguished words of self annoyance alike to I don't have to tell you that. I asked if **“did you say that Glenn was interstate.”** Abrasive McGregor said – I said that he was in another part of the state. I informed that I would telephone next week and if could leave a message that I rang today. He answered yes. I then said that could you with that message tell him that I will ring on Wednesday. He answered that he would.

Comments: Detective McGregor most likely was Kaan McGregor. Unfortunately the name did not registrar with me until after I finished making the call. From the day in 2012 when I spoke with McGregor and Moorefoot in which both were very non frontal – very clean skin-straight like and very nicely suited the abrasive aggression obvious in McGregor's voice was surprising. He certainly sounded very short in tolerance and alike to coming down from a high from substance use. I consider that he as well failed to recognise my name until after the call yet am paradoxed in this when in thought of if he said your Ted. I am pretty certain he was saying team Ted to himself in annoyance and amusement at the code name yet remembering Ed Snowden the informer was/is in the news and is in Russia. If such be it takes me further in certain that McGregor was in a immature state of narcotic use like a speed addict in that he been unable to contain himself from such things as rectricing to himself. I suspect he may well have been the only officer in the Detectives section when he took the call.

Notes: from telephone call made on Wednesday 31st July at around 11:15am from payphone just down from birth and registry office in Haymarket.

Call received by Detective Joyce. Informed him that I knew Glenn was in another part of the State and was told by Detective McGregor on Friday that Glenn was due back next week and that I told McGregor that I would ring on the Wednesday. Detective Joyce informed that Glenn was not in the office and was due back on Friday/will be in the office on Friday. I informed that I would telephone on Friday and if he could inform Glenn of such. Detective Joyce said that he will that he will **“e-mail”** him.

Notes: from telephone call made on Friday 2nd August at just after 11am from same payphone as 4th July.

This time there was no intercept noise after dialling the 88. No one answered after letting the ring through go for a over-normal length of wait time.

Such been reinforces the likeliness that my guess that McGregor was the only one in the Detective section on 26th July as been correct.

Tried again at approximately 11:20am from the front payphone outside Engadine Post Office. After a long ring through was answered by a Mathew Heffernan – unsure if he was a Detective or other. He informed that Glenn was not in the office. I informed that I was informed by Detective Joyce on Wednesday that he was due back in today and does he know when Glenn will be back in the office as well as informing who I was. He answered that Glenn will be back in the office on Monday. I informed that I shall telephone on Monday.

Notes: from telephone call made on Monday the 5th August at just after 11am from same payphone as 4th July.

Received by: Detective Oldfield.

Informed that- **Glenn was in a meeting that will be going for at least another hour; asked if I could give my telephone number.** Informed that- **I don't have a telephone and that Glenn has my postal address.** I suggested- **that Glenn most likely would want to have lunch after the meeting and that I proposed to ring at around 2pm.** Detective Oldfield acknowledged that he shall pass that onto Glenn.

I rang at approximately 2:10pm from the south bound platform at Jannali train station.

Call received by Detective Oldfield who transferred me through to Glenn.

I began by asking **-if he read the 12th June communicay.** He answered **“yes.”**

I continued by declaring that- **I understand that he never was on ANCUD and that I wanted to say- that I regarded Detective Jubelin as very brave for forwarding the DETAIL too The Commissioner.** Glenn was non committed in this with only a type of registered type of very soft – **rrrrrr-errrr yeah.**

Glenn then attempted to front foot by saying in a calm voice something alike to – **I need to say ;;;; -** as if like a teasing lead that he was about to compliment me. And then said- **“that I need help”.** I answered- **what type of help the same type of help that Detective Jubelin needs.** Glenn answered – **“no that I needed psychiatric help”** and that the letter and my belief of numbers in relation to ANCUD as been **“rambling”.**

I answered – **“you define the 12th June communicay as rambling”.** He answered **“yes”** and 90% certain this is where he went into his regard of the numbers.

I answered – **“you're fucking ludicrous” - in the fact firstly that the 12th June communicay had numerous referrals back to the DETAIL and that he has never read that document.** This I sensed baulked him into dearthment. I continued front footed with – repeating my regard of Detective Jubelin and saying that there **“never was a Strikeforce ANCUD”.** Incredibly Glenn answered – **“that's correct”.**

Of then the train was pulling in and that in complete likeliness Glenn would have heard the sound of the train. I informed- **that I had to go and catch the train** and in same asking –**“if he made an inquiry regarding the 14 year old boy.”** Glenn answered – **“no he did not”.**

I furthered adding- **that I have delivered copy of all the communicays to the Police Commissioners Office.** There seemed to be a type of registered baulk here. I then - **suggested he go too the Kings Court Massage Parlour website** – Glenn responded by

saying – **“no I don’t want to go there”** all along speaking in that soft calm voice. I followed with- **that on the Kings Court website is a Big Johns site that shows inside the parlour and that on page 5 there’s a red payphone box and inside there’s a man who I am not quite certain who it is but it looks like someone very familiar.** Glenn now completely and totally through his nose and out ov the calm soft voice into a soft offended tone said that – **he never worked on ANCUD and that there was no need for him to speak to me any further.** I finished the call with – **“that’s right – that’s right”**.

Comments: Detective McGregor on both receives was extremely polite in his voice totally a different to when speaking to him in the foyer. Very deliberate perhaps in a full recall ov how I closed out in the foyer by stating that the next contact I make shall be very important in the response I receive. As well he may have been fully knowing that I was going to telephone that day.
